9.1. Increasing YTY's visibility

Description: YTY's aim is to stabilise a brand and this requires visibility. This can be implemented by for example participating in different events and keeping in contact with its membership.

11. Socio-political matters

11.1. Finishing the Equity Plan

Description: Yhdenvertaisuussuunnitelma toteutetaan TREYn ohjeiden mukaisesti monivaiheisena prosessina, jossa otetaan huomioon jäsenjärjestöjen toiveet ja tarpeet, sekä YTY:n oma toiminta ja arvot. Koko hallitus osallistuu työn tekemiseen, mutta tehtävän vetovastuussa ovat sosiaalipoliittinen vastaava sekä mahdolliset muut tehtävään valittavat henkilöt. Yhdenvertaisuussuunnitelmassa hyödynnetään jo vuonna 2021 aloitettua pohjatyötä sekä olennaisia yhdenvertaisuuskyselyitä. Prosessin aikana päätetään myös YTY:n oman yhdenvertaisuuskyselyn tekemisestä. Tavoitteena on tehdä yhdenvertaisuuskysely kevään 2022 aikana, jotta kyselyn tuloksia voidaan hyödyntää yhdenvertaisuussuunnitelman luomisessa.

Proposition:

Discussion: The aim is to complete the plan by autumn 2022. The entire membership will participate in the creation of the plan. The second goal is to additionally create an equity survey: the survey will act as a comparison point to last year and also helps assembling the equity plan. We strive to ensure the contents of the equity survey from the Dean.
