11. Organizational matters

- 8th of November a meeting with the Dean was held
 - The faculty has given a statement which is coterminous with YTY's and the students concerning the premise reductions.
 - In the future the objective is to arrange similar student organisation rooms as are already arranged in Hervanta.
 - The majority of the support services will move from the main building to Hervanta thus creating new free spaces to the main building.
 - The student organisations of SOC who do not yet have their own room; the faculty is aware of the situation and the matter is being processed.

- Graduating students with difficulties being accepted to mandatory language courses held by the Language Center; suggested strategy is to directly contact the Language Center concerning the matter.
- Faculty aid will not be systematic next year meaning the aid funds will not be automatically transferred to all student organisations. The aid is event specific and it is free for application through YTY.
- The aim in the future is to be in contact with member student organisations' socio-political officials and tell them of the upcoming development of YTY's equality plan.
- Objective is to make a feedback form to all members, concerning the year 2021.

12. Education policy matters

- An educational affairs meeting on the 27th of October the arranging of an info event concerning Sisu's database was discussed, by the students request. Bilingualism in the administration and university's activity was brought up in the meeting.
- TIPSY's degree has had issues concerning financial aid funds and the matter is being processed on faculty level.
- YTY has in addition participated in the Defend Linna (Linnasta ei luovuta) movement's protest and shows its support to the movement.
- The educational affairs officials of YTY and Interaktio have discussed issues detected in the Sisu database concerning the Master's program Social Psychology in the Social Sciences degree. Problems arise in course signup with students who have previously accomplished courses from another university. The matter is acute and the aim is to handle it with the Head of the Education Department.
- YTY's educational policy official has participated in TREY's Cup of Kopo (Kupillinen Kopoa) meeting where discussion topics covered, including, hybrid teaching alongside the course signup of the Language Center.
